It was **NOTED** that Condition 3 requires that no demolition shall take place until a licence has been issued, that a Natural England Mitigation Licence has been granted and that demolition should be monitored for compliance with the terms of the method statement.

The LPA decided applications were **NOTED**. It was further **NOTED** that an appeal decision relating to The Bay Horse was issued on 8 August as follows:

- It was part dismissed and part allowed.
- The Inspector has allowed the pub to change use to a coffee shop;
- A condition has been imposed removing permitted development rights meaning that the owner cannot change from a coffee shop to some other use in Class E without first applying for planning permission;
- The fencing to the front and the design of the new porch were dismissed as harmful elements of the conversion.
